

Cybersecurity Paid Internship



Join the Gauchito Security Operations Center (GSOCC) and make a difference while preparing for a career in Cybersecurity. Glendale Community College GSOCC serves the growing cybersecurity ecosystem in Arizona by investing in building competency-based platforms, creating career-ready pipelines for students, and engaging with partners locally while striving to meet the needs nationally.

OVERVIEW

Student interns (employees) will work as part of the GSOCC project, which provides Security as a Service (SECaaS) to critical cyber/physical assets of rural and remote clients in Arizona. Interns will receive skill development as an Analyst while helping to monitor, detect, and inform against security breaches on clients' network and other operations. The experience students will gain will help prepare them for full-time roles as Information Security Analysts upon completion of their degree program and this internship.

Once the GSOCC is fully operational, there will be 12, paid internship positions available each fall and spring semester. Students must complete CIS298AC using required training materials through EC-Council prior to enrolling in the paid internship course of CIS290AC.

Students will be required to complete a 2-week refresher course between the completion of CIS298AC and the start of CIS290AC.

INTERNSHIP

CIS290AC is the Paid Internship course for this program. Once selected for the course, students will:

- Be required to work 19.5 hours per week for 15 weeks during the fall or spring semester.
- Compensation will be \$16 per hour and will not exceed \$4,680 for the semester.
- GSOCC provides client service Monday-Friday, between the hours of 9:00 a.m. and 1:00 p.m.

SELECTION PROCESS

This is a competitive application process because there are limited positions available. Students must submit a resume and cover letter as part of the application process and email to GSOCC@gccaz.edu.

Students must have completed CIS298AC using course materials from the EC-Council CSA prior to enrolling into the paid internship course - CIS290AC.
